

## Apostle Aurora II Australia Fund

### Managed Investment Trust Notice

The Apostle Aurora II Australia Fund is a Managed Investment Trust for the purposes of subdivision 12-H of Schedule 1 of the Taxation Administration Act 1953 ("TAA 1953").
